IDENTIFICATION

Travel within USA

All airlines will ask for identification when you check-in. It is recommended that you carry a passport if you have one. A driver's license (with a photo I.D.) is also acceptable for domestic flights.

Cancellation Charges for this tour: After your seat reduction date has passed, a non-refundable deposit will be retained. For Cancellation between 60-16 days prior to departure: cancellation fee of 20% of total price. For cancellation between 15-1 days prior to departure: cancellation fee of 40% of total price. For cancellation on the day of departure and after: 100% of total price. For Ocean Cruises: For cancellation between 90-61 days prior to departure: cancellation fee of 25% of total price. Harvard Campus Tour with the Glass Flowers Exhibit & Longfellow House \$45 USD

Cross the Charles River to tony and scholarly Cambridge for a tour of Harvard University's campus. Harvard is the oldest institution of higher learning in the United States, founded in 1636. Its alumni include seven U.S. Presidents, including both Roosevelts and John F. Kennedy, as well as more than 40 Nobel laureates. Learn Harvard's fascinating history as you explore its wealth of architecture spanning from the colonial era to the present. Venture out into trendy Harvard Square, bustling with pedestrians, and enjoy lunch on your own in one of the square's many diverse restaurants. Harvard Square was the site of vibrant folk music scene of the early 1960s. After lunch, discover The Glass Flowers at Harvard's Museum of Natural History. It took glass artisans Leopold Blaschka and his son, Rudolph, five decades to carefully craft the 3,000 glass models of more than 830 plant species. A short way out of the square is the home of beloved American poet, Henry Wadsworth Longfellow, who wrote "Paul Revere's Ride" and "the Song of Hiawatha". Tour Longfellow's mansion, now a National Historic site. The house was historic long before it was even his, as George Washington commanded the Continental Army while headquartered there. *Duration: Approximately 3 hours.* Please note a minimum of 10 passengers is required. Transportation is included.
